BJD uses public money for its publicity: Opposition

Bhubaneswar, August 2: With the BJD government's move to put up hoardings and banners at all prominent places of the state, Opposition Congress and BJP alleged that BJD wants to do publicity by misusing public money.

The Information and Public Relations secretary, Hemanta Sharma, has recently directed the Collectors to reserve hoarding posts in urban local bodies, panchayats and major congregation places in rural areas for putting up state government's advertisements. The advertisements will be placed for publicity of state's achievements.

Collectors were directed to reserve hoarding posts for putting up state government's advertisements

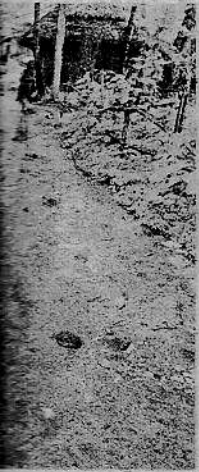
(PCC) president Niranjan Patnaik said, the BJD and its government has booked all the spaces to put up their hoardings and banners and there is no space for others.

"They are doing so to ensure that no other hoarding other than the ones bearing a picture of Naveen Patnaik is allowed. Through this, the BJD government is trying to do publicity on public money," Patnaik maintained.

State BJP spokesperson Golak Mohapatra has criticised the government over the issue. The BJD government has not left even an inch of space as it plans to put up posters of CM Naveen Patnaik everywhere. "All such spaces would be subsequently used during elections for their advertisements," he stated.

However, BJD spokesperson Sasmit Patra refuted the allegations of the opposition parties and said, "The government has recently launched several schemes including Biju Swasthya Kalyan Yojana, plastic ban, its own Food Security Act which need to be publicised to help aware people of the welfare schemes of the government."

- Bhagirathi reminds one of the famous story 'Budhasankhari' (old bangle seller) written by poet Kantakabi Laxmikant Mohapatra.
- Simply clad, Bhagirathi is known to almost all households in the Aradi area. Some call him Bhagi Bhai and others call him Bhagi Mause.

"I have land, but that is not cultivable. So I have to purchase rice throughout the year," he said.

He believes that if someone can work hard without expecting government help, he can manage his family well.

"As long as I am healthy I will be selling bangles in villages. Meeting people really gives me joy," Bhagirathi said with tears welling up in his eyes.

All his sons work in private companies. "When I return home in the evening after selling bangles my wife Hemalata takes care of me. I like food cooked by my daughters-in-law. My favourite is mushroom," he said.

In the evening, he reads the Bhagwat Gita and entertains his grandkids by telling folktales. He has been receiving ₹300 per month as pension, but has not been able to build a pucca house. However, no ration card has been provided to his family.
