Workers' stir hits production at Essar plant

Paradip, Nov 9: Workers of Essar Steel staged protests at its main gate Friday, halting its operation. Members of Essar Steel India Workers' Union have put forth over 15 points of demands.

Some worker alleged hat they had planned to stage stir May 26, but the administration imposed prohibitory order here, thus scuttling the agitation.

Later, attempts were made to sort out the issue with the company management, but no officials urned up. Their demands included EPF, ESI, minimum wages and bonus. They also pointed out that six of the workers were laid off without notice. Transportation to the plant was disrupted by the strike.

Abortion death: NHRC seeks info

Kendrapara, Nov. 9: The National Human Rights Commission (NHRC) has asked Jagatsinghpur SP to submit the status report of Raghunathpur PS case no: 11 dated February 13, 2018 that involved the death of a girl due to an illegal abortion. It asked the secretary of the department of health and family welfare to submit a report within six weeks regarding action taken against the clinic of Dr Haramani alias Mamata Moharana where a girl died due to an illegal abortion.

The NHRC had been monitoring the case after a petition was filed by human rights activist Radhakanta Tripathy. Tripathy said the body of the girl was found in a forest that she

died while carrying out an illegal abortion.

The girl's family tried to hide the case. Negligence by the health officials and the district administration in taking action on the issue is a serious violation of human rights, Tripathy told the NHRC. He requested the NHRC to probe the case and take action against errant officials and order compensation to the victim's family.

The Jagatsingpur SP told the NHRC that Ravinder Malik, the in-charge of Raghunathpur PS registered a case under Sections 302, 201 and 34 of IPC and investigations were initiated.

During the probe it was found that the girl was a Plus II student of Rahama College in 2013. She was staying with her parents. The father of the girl was told his daughter was pregnant. She was taken to a doctor and some drug was given. When there was no result the girl was taken to Mamata Clinic in Jagatsinghpur February 9, 2018.

The doctor and a nurse performed an abortion on the girl. During the abortion the girl's condition deteriorated and she died.

After this the father of the girl with the help of the doctor and staff packed her body in a gunny bag and dumped it in the forest. During the investigation, six persons including the father of the girl and the doctor were arrested. There was sufficient evidence against them. Tripathy said the report admits that the death was due to the abortion and that it was completely illegal even though it was carried out by a qualified doctor.
